50 Years... and Counting

From the Chair of the Board, Mary Burnett

Serving on St. Matt's Board has been one of the most meaningful roles of my life. Over the past six years, I've witnessed this organization meet enormous challenges with courage, care, and a shared commitment to doing what's right—even when the path wasn't easy.

At the start of my term, we faced tough financial realities that meant selling off several supportive housing homes. It wasn't a decision taken lightly, but we ensured those units stayed in the community by transferring them to another provider. Around the same time, we made the difficult choice to close our food bank—recognizing that emergency food relief alone wasn't enough. Instead, we launched food delivery for older adults and cooking classes in social housing communities—efforts that became vital during the pandemic.

COVID brought new pressures, including the request to take on a second child care centre. Experts advised against it, but we couldn't ignore the potential loss of spaces for local families. Today, St. Matt's at St. Peter's is thriving, and our partnership with Adelaide Hoodless Elementary continues to grow.

When our building at 412 Barton was deemed unsafe, we saw opportunity in the challenge. Inspired by a bold vision from our Executive Director, we decided to develop the site into supportive housing for Black and Indigenous seniors facing homelessness. That building is nearly complete, and thanks to partnerships with ACCA and HRIC, it will offer culturally-informed support and care.

In 2022, as homelessness surged, we joined with the City and the Diocese of Niagara to expand the Cathedral's drop-in café. It now operates six days a week, serving meals and connecting thousands to vital services. In 2024 alone, it welcomed over 57,000 visits and served 75,000 meals.

Behind the scenes, we've been strengthening both the organization and the board—especially our shared understanding of equity, diversity, inclusion, and belonging. These values are the compass that guide every decision we make.

To our Executive Director, staff, volunteers, board, and supporters—thank you. Your vision, tenacity, and heart are what keep St. Matt's moving forward.

Here's to 50 years of community. And here's to the next 50—together.



Our Seniors Support Services and Street Outreach Team support vulnerable seniors (55+) and unhoused individuals in Hamilton. We address their diverse needs by connecting them to tax assistance, food banks, housing support, and medical care.

HOPES (Housing Outreach Preventing Evictions for Seniors) helps seniors maintain stable housing. Our unique anti-eviction program, in partnership with the Hamilton Community Legal Clinic, has prevented evictions, preserving affordable housing units and curbing rent increases. We deliver boxes of groceries to combat food insecurity and our year-round Mobile Fresh Food Market and SinKs (Seniors in Kitchens) programs ensure consistent access to healthy food for seniors.

Our commitment to Equity, Diversity, Inclusion and Belonging (EDIB), as well as ongoing Truth and Reconciliation training, is essential to the heart of our work. We're dedicated to building inclusive spaces where every child feels seen, valued, and celebrated. These efforts are made possible by our exceptional staff—whose compassion, energy, and care shape every child's experience.

Cathedral Café

The Cathedral Café is a daytime welcome centre and a collaborative partnership between St. Matt's and Christ's Church Cathedral, alongside the Anglican Diocese of Niagara and the City of Hamilton.

The hub at Cathedral Place on James Street North, provides safe and supportive daytime drop-in space for homeless individuals and those at risk of homelessness. Guests are able to access seating, warmth, friendly welcoming faces, activities, programs and services such as health and ID clinics, pet supplies, washrooms and food, with the main focus being to provide breakfast and lunch daily—along with the simple need for a place to be.

Celebrating Partnerships with the City of Hamilton Housing Secretariat

The quest of 412 Barton is to provide deeply affordable homes so that 15 Indigenous and Black seniors at risk can thrive, alongside wraparound support. As an organization affiliated with the Anglican Church, which has a deep history in the residential school system, we see this as meaningful action toward truth and reconciliation with Indigenous peoples. We also acknowledge the Black community's history of slavery and colonization, often supported by institutions like the Anglican Church, and aim to address this legacy as well.

The new building will include a community kitchen and social space, as well as a healing garden. It's intended that it will be a beautiful outdoor space where culturally appropriate-led programming can be offered, but also as a place where seniors who call 412 Barton home will be able to interact with children from the childcare program for multi-generational programs and activities. It will bring elders, seniors, and community partners together in friendship to contribute to the physical, intellectual, emotional, and spiritual well-being of Indigenous and Black older adults in Hamilton.



Celebrating construction and partnership progress

In the journey to completion of the 412 Barton Project, we held a very special Commitment Ceremony in November 2024. The goal was to celebrate a construction milestone with a closed-in structure and the support from the City of Hamilton and the Housing Secretariat team in reaching this point.

The Ceremony shared in the acknowledgment of the past, learning in the present and commitment to a future of collective healing with respect and reconciliation. The celebration infused with respect, rituals and words that honour its future residents and the process to create these homes. St. Matt's was proud to honour City of Hamilton Housing Secretariat Justin Lewis and the team at the City of Hamilton Housing Secretariat in the shared commitment to Truth and Reconciliation and rights for the Black Community.

More than 50 people, including Justin Lewis and the team from the Housing Secretariat, Bishop Bell of the Anglican Diocese, Bishop Crosby of the Catholic Diocese, partners and collaborators from the Afro-Canadian and Indigenous communities, our development and construction partners from New Commons Development, Assembly and Jackman Construction as well as St. Matt's staff, stood in acknowledgment of the journey to this point in the 412 Barton journey, and everyone signed the walls inside the front door, so the community support is literally built into the structure and future homes.



Fundraising Initiatives

Walk for St. Matt's

One of the new ideas that we saw in 2024 was the Walk for St. Matt's, in collaboration with the Workers Arts and Heritage Centre. Walkers stepped into the vibrant tapestry of Hamilton's North End with the family-friendly event, where history came alive through an enchanting walking tour. Participants enjoyed uncovering the captivating tales woven into the very fabric of this journey, exploring a community that is the heart and soul of Hamilton.



Participants raised more than \$12,000, well ahead of the \$10,000 goal, and all to support the multitude of programs and services that St. Matt's offers.

Building Homes Through Rock and Roll

The Holk Family passionately believes in the power of community and the magic of music in bringing people together. How fortunate then, that they are patrons of St. Matt's and its 412 Barton project. In May 2024, the family staged an epic evening of rock and roll tribute, a powerful showcase of the most iconic acts in rock music history. From the triumphant Tina Turner to the mesmerizing charm of Freddie Mercury, with the exuberant stylings of Rod Stewart to the harmonious tunes of the Bee Gees, the tribute artists gave unforgettable journey through life's soundtrack.



Financial Report

Revenues for the 12 months ending December 31, 2024 were \$6,273,958 versus \$3,733,361 for the 9 months ending December 31, 2023. Expenditures for 2024 were \$6,142,926 versus \$3,518,108 for the prior 9-month period. The higher revenues and expenditures are primarily attributable to the full year operation of the Cathedral Café in 2024. In the prior year, the Cathedral Café was operational for just one month. Excess of revenues over expenditures from operations for 2024 was \$131,032 compared to \$215,253 for the prior 9-month period.

Land and African Ancestral Acknowledgment

We would like to acknowledge that the land upon which we reside is the traditional ancestral territories of the Mississauga, Haudenosaunee and Anishanaabe nations, and within the lands protected by the "Dish with One Spoon" wampum agreement.

For many thousands of years, the first people sought to walk gently on this land. We seek a new relationship with the original peoples, one based in honour and deep respect. We acknowledge all our ancestors that have walked and stewarded these lands before us and those that continue to walk with us on this journey to a more harmonious world.

We have gratitude for the opportunity to engage in and demonstrate leadership on reconciliation, in embracing diversity, and in helping everyone thrive, which is what we aim to do in St. Matt's through our programs and practices.
